

BHS Pupil premium strategy statement

Part A: Pupil premium strategy plan

Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress, achieve high attainment across the curriculum and continue to develop their social skills through fully inclusive funding for trips and visits.

The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already higher attainers.

High-quality teaching is at the heart of our approach, with a focus on areas (Maths & English, specifically reading) and 'challenge for **all**'; in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure *all* inc. disadvantaged pupils are challenged, in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Our assessments, observations and discussions with pupils and families suggest that the education and wellbeing of many of our disadvantaged pupils have been impacted by partial school closures to a greater extent than for other pupils. These findings are backed up by several national studies. This has resulted in significant knowledge gaps resulting in pupils falling further behind age-related expectations, especially in Year 7 English; particularly literacy and confidence with oral skills.

2	Our assessments (including wellbeing survey), observations and discussions with pupils and families have identified social and emotional issues for many pupils, such as anxiety, depression (diagnosed by medical professionals) and low self-esteem. This is partly driven by concern about catching up lost learning and exams/future prospects, and the lack of enrichment opportunities due to the pandemic. These challenges particularly affect disadvantaged pupils, including their attainment. During the pandemic, teacher referrals for support markedly increased. Specific students receive extra support in 1-1 or small groups in the Hub or with PP mentors. Trips funded to all PP students- one full a year and subsidised when parental requests.

Part B: Review of outcomes in the previous academic year

Pupil Premium Mentor Impact Report (2024–25)

The Pupil Premium Mentor has played a pivotal role in improving outcomes for disadvantaged and EAL learners at Boston High School. Her work has delivered measurable impact across well-being, academic progress, and engagement, fully aligned with the objectives of Pupil Premium funding.

Key Areas of Impact & Compliance Statement

This report meets the Department for Education (DfE) statutory requirement to publish an annual review of Pupil Premium spending and its impact. The Pupil Premium Mentor role is fully funded through the Pupil Premium allocation and is integral to our strategy for closing attainment gaps and supporting disadvantaged learners.

1. Wellbeing & Resource Support

- Introduced termly Microsoft Form check-ins for PP students, achieving **73% engagement in Term 5**, enabling rapid (two-week) turnaround for support requests and reducing stigma.
- All form tutors of PP students are contacted on a termly basis, for an added well-being/ academic check-in.
- Term 2 2025 Microsoft Forms are now differentiated focussing on balance of well-being, stress and academic management for KS3

2. Enrichment Access

- Coordinated Year 10 PP trip to **FutureFest**, enhancing career aspirations and engagement.
- Completed **MIDAS training** to streamline future enrichment logistics.
- (2025-26) Investing in a Y8 cultural capital project which included a supported visit to St Botolph's Church, **Rhubarb Theatre Company** working on costume making project, buffet provision and participating in the **Illuminate Parade**.
- **(2025-26)** All PP students that attend after school activities are provided with snacks and a drink after school.

3. Parental Engagement

- Contributed EAL-focused content to literacy newsletters, signposting adult ESOL courses.
- Maintained liaison with Year 9 parents to report progress and confidence gains.
- **Y7 introductory email during transition** from Y6 explaining KS role as signposted contact and liaison to be able support parents with purchases.
- Established a dedicated **PP contact email** for timely support.
- Y8 PP project which has allowed to meet parents in person

4. Neurodiversity Support

- Delivered dyslexia-specific strategy sessions during Easter School, supporting ND learners.
- (2025-6) SEN resources purchased for PP including overlays and fidget toys
- Dyslexia friendly font for KS4 literature texts including Macbeth & A Christmas Carol
- Rapid Plus Programme purchased for KS3 struggling readers

6. Targeted Academic Interventions

- **Year 12:** Academic writing workshops for EAL/PP students improved written work in RS and Sociology.
- **Year 11:** Intensive interventions for high-need PP/EAL learners; scaled language support from fortnightly to weekly sessions, achieving **73% attendance**.
- **Year 10:** Increased English support sessions for underperforming PP/EAL students.
- **Year 9:** Twice-weekly Literature sessions for 32 students below reading age (32% EAL, 14% PP) to build GCSE readiness.

7. Tracking & Digital Learning

Implemented a **tracking sheet** for KS3 PP/EAL language assessment data to enable early intervention.

8. Future Plans

Term 3 - 2026

A focus on extra-curricular lunchtime activities to improve engagement:

- Microsoft Forms for students to be fully informed on declining activities
- Taster sessions
- A suggested 'Freshers Style' week for all activities to be available (SLT approached)

2) Use of PP Salary within Maths Team (Years 7–11)

We have employed an additional teacher to enable targeted intervention for PP and students most in need. This has allowed experienced staff to deliver small-group and one-to-one sessions focused on closing gaps in understanding, particularly in core topics identified through assessment data.

Support, Planning, and Leadership

- Coordinated intervention timetables to ensure PP students receive regular, high-quality support without missing core curriculum time.
- Led planning for differentiated resources tailored to PP students' needs.
- Oversaw progress tracking and liaised with classroom teachers to align intervention with classroom learning.

- **Additional Resources**

PP funding has also been used to purchase essential learning resources for disadvantaged students, including scientific calculators, revision guides, and workbooks. These resources have supported independent study and ensured that PP students have the same access to high-quality materials as their peers, reducing barriers to learning and improving engagement with homework and exam preparation.

Impact

- Increased frequency of targeted sessions for PP students across Years 7–11.
- Early indicators from recent assessments show improved performance in key areas for PP students compared to baseline data.
- Attendance at intervention sessions has been high, and feedback from students suggests increased confidence in maths.

- **Next Steps**

Maths HoD is currently exploring effective ways to analyse impact data, such as:

- Comparing progress scores for PP vs. non-PP students across assessment points (New implementation of the Formal Agenda).
- Monitoring movement between attainment bands over time.
- Using question-level analysis to identify specific areas of improvement.

Additional activity

Our pupil premium strategy will be supplemented by additional activity that is not being funded by pupil premium or recovery premium. That will include:

- embedding more effective practice around feedback. EEF evidence demonstrates this has significant benefits for pupils, particularly disadvantaged pupils.
- ensuring pupils understand our 'catch-up' plan by providing information about the support they will receive (including targeted interventions listed above), how the curriculum will be delivered, and what is expected of them. This will help to address concerns around learning loss - one of the main drivers of pupil anxiety.
- utilising support from our local Mental Health Support Team and local behaviour hub, plus funding for CPD to support pupils with mild to moderate mental health and wellbeing issues, many of whom are disadvantaged.
- offering a wide range of high-quality extracurricular activities: 'BHS beyond the curriculum' to boost wellbeing, behaviour, attendance, and aspiration. Activities (e.g., The Duke of Edinburgh's Award), will focus on building life skills such as confidence, resilience, and socialising. Disadvantaged pupils will be encouraged and supported to participate, all letters to parents, for trips/visits to show subsidised funding for PP students.
 - New policy 'Challenge for all' - inclusion for all students, especially PP students. NACE Challenge accreditation framework- BHS community working towards over 2 yrs.

Planning, implementation, and evaluation

We triangulated evidence from multiple sources of data including assessments, engagement in class book scrutiny, conversations with parents, students and teachers in order to identify the challenges faced by disadvantaged pupils. We also used the EEF's families of schools database to view the performance of disadvantaged pupils in school similar to ours and contacted schools with high-performing disadvantaged pupils to learn from their approach.

We looked at a number of reports and studies about effective use of pupil premium, the impact of disadvantage on education outcomes and how to address challenges to learning presented by socio-economic disadvantage. We also looked at a number of studies about the impact of the pandemic on disadvantaged pupils.

We used the EEF's implementation guidance to help us develop our strategy and will continue to use it through the implementation of our activities.

We have put a robust evaluation framework in place for the duration of our three-year approach and will adjust our plan over time to secure better outcomes for pupils.
